STOCK MARKET

VN-Index today struggled around the 1,285 threshold all day. At the end of the afternoon session, the index rebounded to 1,290. However the selling pressure here immediately pushed the index down to close at 1,282.02 points, moving sideways compared to yesterday. Market breadth tilted to the negative side with 11/18 sectors decreasing, of which the Financial Services led the decline, followed by the Basic Resources. On the contrary, Information Technology, Oil and Gas, Chemicals, Retail,... had a positive trading session. Regarding foreign investors, today they continued to net sell more than 1 trillion VND on the HSX. The market still shows hesitation after the previous sharp decline. Investors should trade carefully in the coming sessions.

FUTURES CONTRACTS

Futures contracts all increased according to the movement of VN30.

COVERED WARRANTS

During the trading session on 21/06/2024, warrants fluctuated according to the struggling movement of the underlying stocks.

BSC30, BSC50 PERFORMANCE

- VN-Index **-0.28** points, closing at **1282.02** points. HNX-Index **+0.39** points, closing at **244.36** points.
- Pulling the index up: **LPB (+1.18)**, **FPT (+1.04)**, **GVR (+0.56)**, **PLX (+0.32)**, **SSB (+0.32)**.
- Pulling the index down: **HPG (-0.47)**, **HDB (-0.32)**, **ACB (-0.28)**, **VHM (-0.27)**, **TCB (-0.26)**.
- The matched trade value of VN-Index reached VND **18,665** billion, decreased **-12.44%** compared to the previous session. The total transaction value reached VND 21,429 billion.
- The trading range is 8.62 points. The market had **185** gainers, 78 remaining unchanged, **234** losers.
- Foreign investors' net selling value: VND **-1007.32** billion on HOSE, including **FPT (VND -227.01 billion)**, **VND (VND -128.57 billion)**, **VRE (VND -85.01 billion)**, **HPG (VND -63.41 billion)**, **POW (VND -52.02 billion)**. Foreign investors were net sellers on HNX with the value of VND **-34.57** billion.

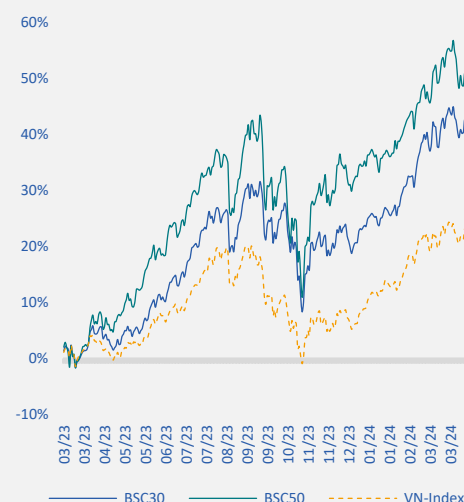

Performances of BSC30, BSC50



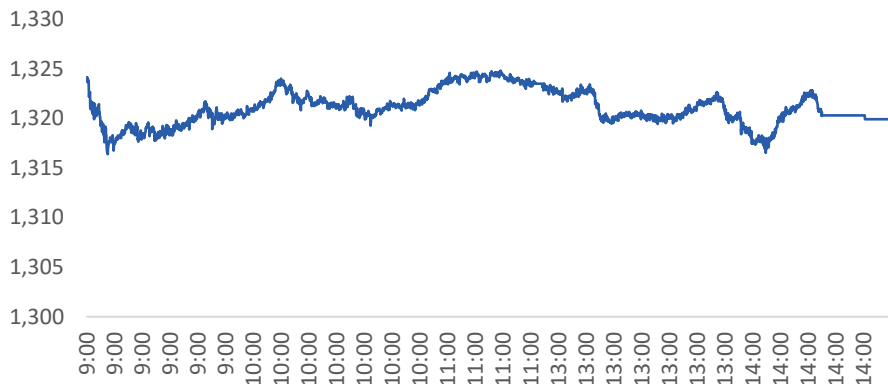

- VN30 -2.43 points, closing at 1319.93 points. Fluctuating amplitude of 8.74 points. Stocks such as HDB, HPG, ACB, TCB, VPB negatively impacted the movement of VN30.
- VN30 ended the session below opening, the index could not overcome the selling pressure today. At the end of the session, the index rebounded with liquidity below the MA20 line. It is recommended that investors trade cautiously during the session.
- Future contracts all increased, except VN30F2412. In terms of volume, all futures contracts increased, except for VN30F2412. In terms of open positions, all futures contracts decreased, except for VN30F2407.

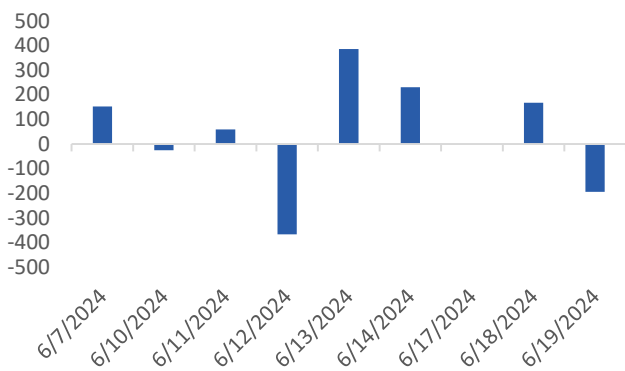
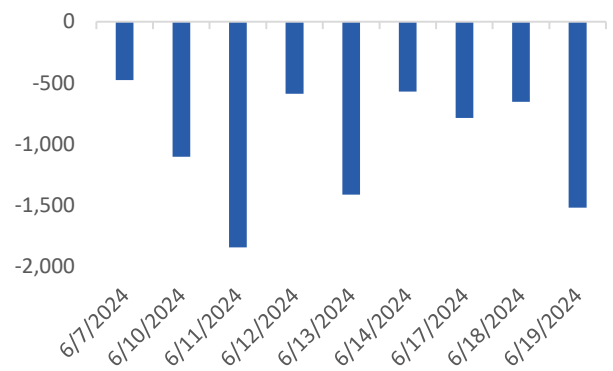
