Market outlook

Stock market: The market struggled in the early morning, then moved up to the threshold of 1,260 before closing at 1,262.33 points, up more than 10 points compared to yesterday. However, today's liquidity dropped, showing that investors were still hesitated when facing the 1.260 zone. Market breadth tilted to the positive side with 15 out of 19 sectors gaining, in which Financial Services and Basic Resources led the market. Regarding the transactions of foreign investors, today they net bought on the HSX and net sold on the HNX. In the coming sessions, the market will probably continue to trade in the range of 1,250-1,260 to accumulate more when 1.260 is still a hard resistance level.

Future contracts: Futures contracts rallied in line with VN30's rebound. Investors should trade cautiously in the next trading session.

Covered warrants: In the trading session on August 12, 2022, the warrants moved in the increase direction of the underlying stock.

Highlights:

- VN-Index +10.26 points, closing at 1262.33. HNX-Index +3.24 points, closing at 303.42.
- Pulling the index up: BID (+1.16), HPG (+0.81), GAS (+0.67), VGC (+0.51), VNM (+0.42).
- \bullet Pulling the index down: VHM (-0.22), VJC (-0.12), SSB (-0.07), HAG (-0.06), PNJ (-0.04).
- The matched value of VN-Index reached VND 12,108 billion, decreased 29.84% compared to the previous session. The total transaction value reached VND 13,038 billion.
- The trading range is 13.68 points. The market had 273 advancers, 81 reference stocks, 166 decliners.
- Foreign investors' net buying value: VND 138.31 billion on HOSE, including HPG (124.98 billion), VIC (25.29 billion), NVL (16.14 billion). Foreign investors were net sellers on HNX with the value of VND -1.24 billion

HSX-Index Intrada






Outlook:

- VN30 increased 8.63 points to 1280.96 points, the fluctuation range was 13.82 points. Stocks such as HPG, VPB, STB, TCB, and VNM have positively influenced the movement of VN30. Although VN30 formed a short-term rebound candle, it moved in a small range with liquidity lower than the 20-day average. The market has not yet shown any trend confirmation signals, the technical indicators are mostly neutral. Investors should trade cautiously in the next trading session.
- Futures contracts rallied in line with VN30's rebound. In terms of trading volume, only VN30F2212 increased slightly, the remaining contracts decreased. In terms of open positions, all contracts increased, except VN30F2208 which dropped sharply.

Outlook:

- In the trading session on August 12, 2022, the warrants moved in the increase direction of the underlying stock.
- CACB2201 and CHPG2212 witnessed the best growth, at 471.43% and 33.33% respectively. Transaction value decreased by -14.53%, CHPG2215 had the most transaction value, accounting for 11.15% of the market.
- CVHM2205, CHPG2206, CHPG2203, and CVIC2202 are warrants whose value is closest to the theoretical price. CPDR2204, CHDB2208, CNVL2206, and CTCB2201 are the most positive warrants in terms of returns. CPNJ2201, CFPT2203, CSTB2214, and CPNJ2202 are the most positive warrants in terms of money position.


