VN-Index continues to rise

Market outlook

Stock market: VN-Index gained more than 27 points today with outstanding liquidity. Market breadth tilted to the positive side with 17 out of 19 sectors gaining, in which the strongest gain of nearly 6% belonged to the Financial Services sector. Regarding the transactions of foreign investors, today they net sold on the HSX and slightly net bought on the HNX. In the next few sessions, the market is likely to continue heading to the next resistance level of 1,120; however, it may not be easy, especially when the index returns to resistance level of 1,100.

Future contracts: Futures contracts increased with the movement of VN30. It is recommended that investors trade cautiously in the coming sessions.

Covered warrants: In the trading session on February 20, 2023, coverred warrants fluctuated along with the uptrend of the underlying stocks.

Highlights:

- VN-Index +27.38 points, closing at 1086.69. HNX-Index +5.88 points, closing at 215.83.
- Pulling the index up: VHM (+2.1), BID (+1.77), VPB (+1.72), HPG (+1.33), MSN (+1.14)
- Pulling the index down: PGV (-0.07), TRA (-0.04), STG (-0.02), CVT (-0.02), PAC (-0.02).
- The matched value of VN-Index reached VND 10,502 billion, increased 52.53% compared to the previous session. The total transaction value reached VND 11,705 billion.
- The trading range is 28.45 points. The market had 383 advancers, 52 reference stocks, 42 decliners.
- Foreign investors' net selling value: VND -12.28 billion on HOSE, including VHM (-66.37 billion), DCM (-47.72 billion), DXG (-41.05 billion). Foreign investors were net buyers on HNX with the value of VND 9.65 billion.
