VN-Index dropped sharply

Market outlook

Stock market: VN-Index opened with a gap down. After a struggling day in the zone of 1,060-1,075, the index closed at 1,054.28, down more than 2.5% compared to yesterday. Market breadth skewed to the negative side with 17 out of 19 sectors dropping, in which the Oil & Gas sector that led the gain yesterday fell the most today, as well as Financial Services, Chemicals, Real Estate sectors. Regarding foreign investors' transactions, today they continued to net sell on the HSX (the strongest net selling in VIC and VHM) and net buy on the HNX. The strong drop with significant liquidity showed that market sentiment is negative, therefore, investors should trade cautiously.

Future contracts: Futures contracts decreased with the movement of VN30. It is recommended that investors trade cautiously in the coming sessions.

Covered warrants: In the trading session on February 22, 2023, covered warrants fluctuated along with the downtrend of the underlying stocks.

Highlights:

- VN-Index -27.95 points, closing at 1054.28. HNX-Index -4.12 points, closing at 209.96.
- Pulling the index up: TMP (+0.04), HQC (+0.03), STG (+0.03), SII (+0.02), BWE (+0.02).
- Pulling the index down: VHM (-2.73), BID (-1.57), VCB (-1.43), VIC (-1.24), CTG (-1.13).
- The matched value of VN-Index reached VND 11,660 billion, increased 12.06% compared to the previous session. The total transaction value reached VND 12,737 billion.
- The trading range is 19.65 points. The market had 60 advancers, 47 reference stocks, 364 decliners.
- Foreign investors' net selling value: VND -362.78 billion on HOSE, including VIC (-58.56 billion), VHM (-53.99 billion), DXG (-39.05 billion). Foreign investors were net buyers on HNX with the value of VND 55.94 billion.
