Market outlook

Stock market: The market continued to recover and closed at 1,118.46 points, up nearly 7 points compared to yesterday. Market breadth tilted to the positive side with 15 out of 19 sectors gaining, in which Basic Resources led the way. Regarding the transactions of foreign investors, today they net bought on the HSX and net sold on the HNX. Today's recovery session has improved liquidity, showing that the current market sentiment is still positive. In the short term, the market may soon return to the 1,125 resistance area.

Future contracts: Futures contracts increased according to the movement of VN30. It is recommended that investors trade cautiously in the coming sessions.

Covered warrants: In the trading session on June 21, 2023, covered warrants fluctuated along with the recovery of the underlying stocks.

Highlight:

- VN-Index **+6.74** points, closing at **1118.46**. HNX-Index **+3** points, closing at **231.77**.
- Pulling the index up: **HPG (+1.42)**, **GVR (+0.72)**, **VNM (+0.42)**, **VIC (+0.38)**, **MSN (+0.32)**.
- Pulling the index down: **VHM (-0.54)**, **GAS (-0.33)**, **VJC (-0.15)**, **DHG (-0.13)**, **BID (-0.13)**.
- The matched value of VN-Index reached VND **15,523** billion, increased **38.29%** compared to the previous session. The total transaction value reached VND **17,520** billion.
- The trading range is **7.81** points. The market had **323** advancers, **55** reference stocks, **106** decliners.
- Foreign investors' net buying value: VND **37.23** billion on HOSE, including **HPG (136.16 billion)**, **STB (96.99 billion)**, **SSI (50.44 billion)**. Foreign investors were net sellers on HNX with the value of VND **-75.89** billion.

Movement of BSC30 and BSC50:

- BSC30 with positive movements of **HPG (4.02%)**, **GVR (3.72%)**, **KBC (1.91%)**.
- BSC50 with positive movements of **HUT (8.65%)**, **KSB (6.97%)**, **HT1 (6.91%)**.
