Market outlook

Stock market: The market returned to the resistance level of 1,125 today and ended the session up nearly 7 points, recording the 3rd consecutive recovery session. Market breadth tilted to the positive side with 14/18 sectors gaining, in which Travel and Leisure, Personal Goods and Households led the gain. In addition, the Chemical and Real Estate sectors also had a positive session. Regarding the transactions of foreign investors, today they net sold on the HSX and net bought on the HNX. In the short term, VN-Index may accumulate more around 1,125 threshold to gain momentum.

Future contracts: Futures contracts fluctuated according to the movement of VN30, especially VN30F2307 and VN30F2308 had opposite movements.

Covered warrants: In the trading session on June 22, 2023, covered warrants fluctuated along with the recovery of the underlying stocks.

- VN-Index +6.84 points, closing at 1125.3. HNX-Index +0.14 points, closing at 231.91.
- Pulling the index up: VHM (+1.21), BID (+0.7), VCB (+0.47), HPG (+0.37), CTG
- Pulling the index down: BCM (-0.2), GVR (-0.15), GAS (-0.1), FPT (-0.08), VPB
- The matched value of VN-Index reached VND 16,239 billion, increased 4.61% compared to the previous session. The total transaction value reached VND 18,635 billion.
- The trading range is 5.79 points. The market had 314 advancers, 63 reference stocks, 114 decliners.
- Foreign investors' net selling value: VND -415.7 billion on HOSE, including VHM (-583.26 billion), TPB (-50.08 billion), VNM (-39.67 billion). Foreign investors were net buyers on HNX with the value of VND 22.49 billion.

Movement of BSC30 and BSC50:

- BSC30 with positive movements of DCM (+4.13%), DGC (+3.61%), VHC (+3.58%).
- BSC50 with positive movements of CTG (+1.03%), ACB (-0.23%), HDB (+0.27%).



These stocks have a higher beta than BSC30, but are still among the top companies in Banking, Securities, Insurance, Construction, Real Estate, Materials, Logisitic, O&G, F&B, Retail, Industrial Production, and Utilities (Electricity, Water), etc. BSC 50 is evaluated quarterly by BSC experts to ensure that the stocks still meet the given criteria. The BSC50 listing is suitable for bull market periods and has potential for investors looking for short-term trading opportunities.
