Market outlook

Stock market: The market struggled around the 1,075 threshold all day today before closing at 1,176.78 points, almost unchanged from yesterday. Market breadth is quite balanced with 7/18 sectors increasing, with the Retail leading the increase. Regarding foreign transactions, today they were net buyers on the HSX and net sellers on the HNX. Strong fluctuations in trading during the ATC session came from the portfolio restructuring activities of ETFs. In the coming trading sessions, the market may continue to have struggling sessions in the 1,075 - 1,085 point range.

Futures contracts: Futures contracts all increased in accordance with the movement of the VN30. It is recommended that investors trade cautiously in the coming sessions.

Covered warrants: During the trading session on November 3, 2023, warrants fluctuate according to the recovery rhythm of the underlying stock.

Highlight:

- VN-Index +1.25 points, closing at 1076.72. HNX-Index +0.16 points, closing at 218.13.
- Pulling the index up: TCB (+1.51), SAB (+0.82), MWG (+0.74), VRE (+0.68), VHM (+0.6).
- Pulling the index down: VPB (-0.95), SSB (-0.94), FPT (-0.61), VNM (-0.46), MBB (-0.38).
- The matched value of VN-Index reached VND 14,322 billion, increased 3.99% compared to the previous session. The total transaction value reached VND 15,411 billion.
- The trading range is 31.44 points. The market had 253 advancers, 63 reference stocks, 280 decliners.
- Foreign investors' net buying value: VND 241.66 billion on HOSE, including MWG (56.3 billion), VCB (43.45 billion), DXG (37.35 billion). Foreign investors were net sellers on HNX with the value of VND -31.63 billion.

- BSC30 +0.22%. Positive stocks: TCB (+5.62%), MWG (+5.27%), VRE (+4.95%)
- BSC50 +0.45%. Positive stocks: CTD (+6.88%), LCG (+4.69%), HDB (+4.26%)

The BSC50 listing is suitable for bull market periods and has potential for investors looking for short-term trading opportunities.
