### VN-Index continues to increase

#### Market outlook

**Stock market:** VN-Index increased nearly 7 points today and ended at 1,128.93 points. Market breadth tilted to the positive side with 13/18 sectors increasing, of which the Communications led the increase. In addition, the Real Estate and Banking sectors also had a positive trading session today. Regarding foreign transactions, today they were net buyers on both HSX and HNX. Despite having a positive trading session today, VN-Index was not able to overcome the resistance level of 1,130, and liquidity was still weak. The index needs to overcome the resistance area of 1,120 - 1,130 with large liquidity to confirm the recovery trend.

**Futures contracts:** Futures contracts all increased according to the movement of VN30. It is recommended that investors trade cautiously in the coming sessions

**Covered warrants:** In the trading session on December 28, 2023, covered warrants fluctuated along with the uptrend of the underlying stocks.

#### Highlight:

- VN-Index **+6.94** points, closing at **1128.93**. HNX-Index **-0.66** points, closing at **231.35**.
- Pulling the index up: **VHM (+2)**, **VIC (+0.81)**, **SSB (+0.64)**, **VPB (+0.59)**, **TCB (+0.57)**.
- Pulling the index down: **BID (-0.42)**, **GAS (-0.17)**, **HVN (-0.13)**, **FPT (-0.09)**, **ITA (-0.06)**.
- The matched value of VN-Index reached VND **12971** billion, increased **6.28%** compared to the previous session. The total transaction value reached VND **15502** billion.
- The trading range is 10.08 points. The market had **312** advancers, 113 reference stocks, **163** decliners.
- Foreign investors' net buying value: VND **442.35** billion on HOSE, including **VHC(73.31 billion)**, **HCM(52.37 billion)**, **FUEVFNVD(51.26 billion)**. Foreign investors were net buyers on HNX with the value of VND **11.2** billion.

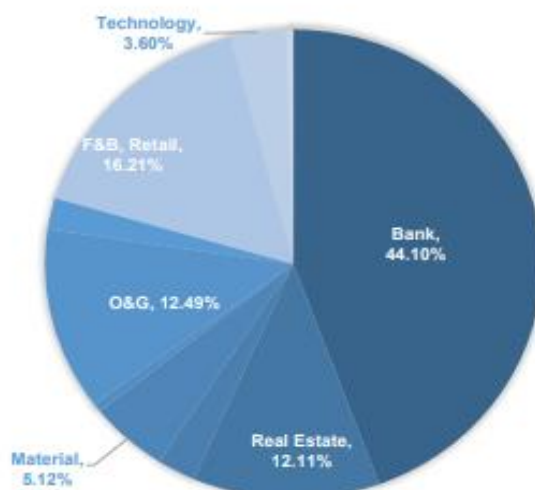

These stocks have a higher beta than BSC30, but are still among the top companies in Banking, Securities, Insurance, Construction, Real Estate, Materials, Logistic, O&G, F&B, Retail, Industrial Production, and Utilities (Electricity, Water), etc. BSC 50 is evaluated quarterly by BSC experts to ensure that the stocks still meet the given criteria. The BSC50 listing is suitable for bull market periods and has potential for investors looking for short-term trading opportunities.
